## Governor Snyder Signs Law for Low Income Energy Assistance Fund (LIEAF)



On July 1, 2013, Governor Rick Snyder signed into law Public Act 95, creating the Low Income Energy Assistance Fund (or "LIEAF") that authorizes the Michigan Public Service Commission (MPSC) to raise up to \$50 million for low income energy assistance payments. The money would come from a surcharge of no more than \$1 per meter per month for all Michigan electric utilities

participating in the LIEAF.

On July 29, the MPSC set the LIEAF surcharge at 99-cents per electric meter per month. However, the charge is limited to only one residential meter per "residential site". For example, if your home and pole barn are located at the same "residential site" and both meters are currently billed at the residential rate, the surcharge will apply to only one of these residential meters. If you have more than one residential meter at the same "residential site" and both meters were inadvertently billed this surcharge, please call our office.

PIE&G will begin assessing the 99-cent surcharge on electric bills generated on or after **October 1, 2013**. The surcharge does not apply to natural gas billings.

## Directors Refund Approximately \$2.3 Million to Members

When you signed up for electric and natural gas service from PIE&G, you became a member of a cooperative. The difference is that while investor owned utilities return a portion of their profits back to their shareholders, cooperatives allocate excess revenue back to its members as "capital credits" that are refunded when the co-op's financial conditions permit.

Last May, your co-op's board of directors approved a refund of nearly \$2.3 million

in capital credits. Members who received service in 1983 - 84, 1992 - 98 and 2011 - 12 will receive a share in proportion to their energy use. **CHECKS WILL BE MAILED IN OCTOBER.**

Until capital credits are refunded, they may be used as operating capital to build and maintain the distribution facilities needed to serve you. It makes sense - dollars and cents - to give credit back to the members who helped build this cooperative through capital credits!

# Fall Furnace CHECKUP

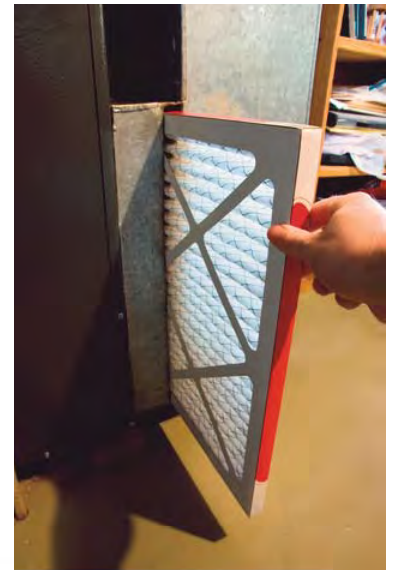
## Stay Warm, Stay Safe & Save Energy

An annual checkup of your furnace by a licensed heating contractor can help reduce

your heating costs and is one of the best ways to help prevent deadly carbon monoxide poisoning.

A checkup now can keep you from waking up in the middle of the night to a cold house later. It could also save lives. Here are other easy ways to help keep your furnace running safely and efficiently all winter.

- Check for rust and corrosion on the vent pipe connected to the chimney.
- Check flues or vents for cracks & obstructions.
- Check the filter once a month and replace it if it is worn or dirty.
- Check the owner's manual to see if the blower motor should be lubricated.
