### HOPPE FAMILY RECEIVES CENTENNIAL FARM RECOGNITION

Since 1921, the Hoppe family has nurtured an 80acre farm in Alpena, Michigan, raising cattle and cultivating crops. This farming legacy continued with Eugene Hoppe, who took over from his father, Florian, in 1947. Eugene and his wife, Leona, grew their family while tending to corn, wheat, oats, hay, potatoes, beef cattle, and ten dairy cows.

In 2022, Leona Hoppe passed the farm to her son, Ron, and his wife, Jackie. This remarkable commitment to one piece of land for a century earned the Hoppe family the prestigious Centennial Farm status.

The Centennial Farm Program began in 1948 with the State of Michigan's Michigan Historical Commission and received support from various

entities, including Detroit Edison Company, Consumers Power Company, farm groups, and local electrical cooperatives like Presque Isle Electric & Gas Co-op.

# GAS LINE SAFETY TIPS

To ensure safety around our natural gas lines, here are some vital reminders:

- **Gas Leak Emergency:** In case of a gas leak, call our dedicated hotline at (800) 655-8565, available 24/7. Please note, this number is exclusively for gas leak reports. For other inquiries, contact us during regular business hours.
- **Immediate Danger:** If you encounter a broken or open gas line with a gas release, call 911 immediately.
- **Pipeline Markers:** Underground gas pipelines are marked periodically with yellow markers. Remember, these markers may not indicate the exact location or direction of the lines. Before any digging, dial 811 (MISS DIG) for free utility marking within three business days. Removing or damaging pipeline markers is illegal and carries penalties.
- **Pipeline Integrity:** PIE&G takes regular measures to maintain the integrity of our natural gas pipeline system. This includes inspections, corrosion control, leak surveys, and pipeline replacements when necessary. Our team is trained to monitor and respond swiftly to gas emergencies, ensuring your safety.

To help keep our community safe, stay informed about these guidelines, even if you're not a PIE&G natural gas service user.
