### Manage My Account

- ⇒ login and password required to access full menu of account tools
- ⇒ make monthly payments and submit meter readings

## DIRECTORS APPROVE \$2.470 MILLION IN REFUNDS TO MEMBERS

Capital Credits from 1987-1988 & 2002-2003 to be Retired

At their April meeting, PIE&G's board of directors authorized approximately \$2,470,000 in capital credit retirements. Members who received electric service in 1987-1988 or 2002-2003 will receive an amount of the above in proportion to their energy use. **Checks for the capital credit refund will be mailed in the fall of 2019.** 

As a member-owned, not-for-profit organization, when PIE&G revenues exceed expenses, "capital" is generated and "credited" to individual members on a pro rata basis, depending on their purchases of electricity or gas.

Capital credits are used to build the facilities needed to serve members or may be retired and refunded whenever the board of directors determines that the co-op's financial condition will not be impaired. Since its inception, PIE&G has refunded approximately \$16.9 million in capital credits back to its members.

#### CO-OPS OBTAIN \$45,000 STATE TAX REFUND FOR MEMBERS

A few years ago, PIE&G, together with other Michigan electric co-ops, sought relief from the State of Michigan for certain sales tax. The cooperatives were successful. The State of Michigan now returns sales tax assessed on positive operating margins.

For 2018, PIE&G generated positive margins for both electric and natural gas operations. Thus, sales tax refunds of approximately \$14,000 will be given back to electric members and over \$31,000 will be refunded to natural gas members. For members receiving a monthly billing, the 2018 tax refunds have been returned as a credit beginning with bills mailed in May 2019. Seasonal members will see the refunds on their annual summer bills. Although the individual refund may be small, it reflects PIE&G's commitment to keeping members' services affordable.

## NOTICE TO MEMBERS OF PRESQUE ISLE ELECTRIC & GAS CO-OP: *ELECTRIC TARIFF CHANGES*

At a Special Open Meeting held March 26, 2019, the Presque Isle Electric & Gas Co-op board of directors accepted the 2018 Power Supply Cost Recovery factor reconciliation analysis indicating an over-collection of power supply costs of \$879,343.17 for the 12-month period ending Dec. 31, 2018 (incorporated in the 2019 PSCR factor).

The board will consider additional changes to the cooperative's rates and tariffs at its Special Open Meeting on May 28, 2019. The following items will be discussed:

- 1. Review and approval of the 2018 Electric Times Interest Earned Ratio (TIER) analysis;
- 2. Consider revisions to the cooperative's Electric Rate Tariffs;
- 3. Consider revisions to the cooperative's Aid to Construction Fees and Policies;
- 4. Consider revisions to the cooperative's Special Charges;
- 5. Consideration of revisions to the cooperative's billing rules.

## LOW INCOME ENERGY ASSISTANCE FUND (LIEAF)

Gov. Snyder signed into law Public Act 95 in 2013, creating the Low Income Energy Assistance Fund or "LIEAF", authorizing the Michigan Public Service Commission (MPSC) to raise up to \$50 million annually for low income energy assistance payments. The money would come from a surcharge of no more than \$1 per meter per month for all Michigan electric utilities participating in the LIEAF program.

In July 2018, the MPSC issued an order keeping the monthly surcharge at 93 cents per meter for the billing period of September 2018 through August 2019. The surcharge is limited to electric bills only and to one electric residential meter per residential site. The surcharge was effective on PIE&G's electric bills generated on or after Oct. 1, 2018, for service rendered in September. Annual bills generated in 2019 will be prorated accordingly.
